MANIFESTATION AND MOTION

[Re: Possible Intimidation Prior to Oral Arguments]

Petitioners ANTONIO T. CARPIO, ET AL. (collectively "Petitioners"), by counsel, respectfully state:

- 1. In its Advisories dated 20 November 2020 and 5 January 2021, the Honorable Court set the instant case for Oral Arguments on 19 January 2021 at 2:00p.m. Multiple motions of the Office of the Solicitor General ("OSG") to cancel the Oral Arguments, have been denied by the Honorable Court.
- 2. On 15 January 2021, Petitioners were informed that upon the representation of the OSG that some of its staff tested positive for COVID 2019, the Oral Arguments were re-scheduled to 02 February 2021.
- 3. On 16 January 2021, Petitioners discovered that a social media post under the name "Antonio Parlade" ("Parlade") had been circulating in Facebook with a message directed against "individuals, groups, and organizations" assailing the Republic Act No. 11479, The

Anti-Terrorism Act of 2020 ("ATA") (the "Post"). Said Post has been widely circulated. The full Post is attached as Annex "A".

4. It appears that there is a Lt. Gen. Antonio G. Parlade, Jr. who is the current Commander Armed Forces of the Philippines ("AFP") Southern Luzon Command ("Solcom") and a member of the National Task Force to End Local Communist Armed Conflict ("NTF-ELCAC").³ Further, it appears that said Lt. Gen Parlade reports to General Gilbert I. Gapay, the incumbent Chief-of-Staff of the Armed Forces of the Philippines.,⁴ who in turn reports to the Respondents in these consolidated cases.

5. The salient portions of the Post state:

"The SC will soon be hearing petitions against the Anti Terror Law. Let's be watchful of these individuals, groups, and organizations opposing a law that will protect our citizens from terrorists. What's their agenda?

The gall of Ferdinand Gaite, Carlos Zarate, Sarah Elago and the rest of these CPP representatives and colleagues, including NUPL.

They speak of the "voice of the people"- these protesters, the noisy and belligerent minority- as if they represent the Filipino people."

6. After an extensive tirade against other petitioners, it then ends with:

"Shall the NTF ELCAC accede? Shall we bend back in acquiescence?

No, we have drawn the line. You decide where to sit.

The Day of Judgement is upon you and the Filipino people, who have suffered enough from the malignant hands of

the CPP NPA NDF of which you are part of, sit in Judgement.

Very soon, blood debts will be settled. The long arm of the law will catch up on you, and your supporters".

- 7. The Post is a clear threat to Petitioners Carpio, Carpio-Morales, et al. for seeking redress before the Honorable Court. Though some portions directly name specific persons, the Post also groups together petitioners as part of "individuals, groups and organizations" who should be monitored for "opposing a law that will protect citizens from terrorists."
- 8. Petitioners believe this is a matter of serious concern that requires judicial remedy as the Post, if indeed made by a State actor, construes the ATA to be able to penalize the right to seek judicial relief before the Honorable Court This is inconsistent with Petitioners' fundamental right to "petition the government for redress of grievances" under Section 4 of the Bill of Rights.⁵
- 9. Designed to intimidate ("blood debts will be paid"), the Post also amounts to interference with the Honorable Court's power to administer Justice, as it is directed to the Parties and their counsel days before the matter is heard by the Honorable Court.
- 10. In addition, the threat falls within Section 4 of the ATA (albeit its constitutionality has still to be passed upon by the Honorable Court as it is one of the issues raised in the present petition), particularly subparagraph 4(a) thereof **which punishes anyone** who "engages in acts intended to cause death or serious bodily injury to any person, or endangers a person's life ...when the purpose of such act, by its nature and context, is to intimidate the general public or a segment thereof, create an atmosphere or spread a message of fear ..." as having committed the crime of "terrorism".
- 11. In view of the above, Petitioners, through this Manifestation, give notice to the Solicitor General, and move that the OSG be required to inform the Honorable Court and Parties ahead of the Oral Arguments on 2 February 2021 as to whether or not the Post is an official statement by the Government or a public officer thereof, including details on the source, circumstances behind and, intent of the said Post.

PRAYER

WHEREFORE, Petitioners respectfully pray that this Honorable Court issue an *Order* DIRECTING the Office of the Solicitor General to SUBMIT before 2 February 2021 to the Honorable Court and all Parties to these consolidated cases a written explanation confirming whether or not the Social Media Post dated 16 January 2021 by an "Antonio Parlade" is an official communication from the Government or a public officer thereof including details regarding the source, circumstances behind and, intent of the Post.

Other reliefs, as may be deemed just and equitable by this Honorable Court, are likewise prayed for.



That's the sad truth Kamatayan bloc, about your old, worn-out narrative of a tyrant of a president: no one buys it but your hundred and one followers.


